

Historical forecast data / hindcasts

Historical forecasts are the archived forecasts that were issued in the past. They are analyzed to see how well a model performs. If a forecast model has not been operating in the past, hindcasts are made, so the model is run with past data to see what it would have forecasted during that time. Historical forecasts and hindcasts are used for forecast verification.
